
On the availability of Bidding Documents, Section 17.3 of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, the Government Procurement Reform Act, mandates the BAC to make available the Bidding Documents from the time the Invitation to Bid is first advertised or posted until the deadline for submission and receipt of bids. The use of the word "shall" in Section 17.3 underscores its mandatory character. **Thus, the BAC cannot limit the availability of the Bidding documents at a date earlier than that mandated by Section 17.3 of the IRR; to do otherwise would be in violation of the mandatory provision of the law and its associated rules.**
